WHAT YOU WILL DO:

- Manage day-to-day field and program-related assignments, while providing support on moderately complex issues.
- Understands and applies company policies and practices to develop solutions.
- Assists in area planning, scheduling, and program implementation.
- Receives general instructions on routine work and more detailed instructions on new work-related assignments.
- Oversees the utilization of Forestry contract workforce within an area of responsibility.
- Work with forestry team to organize and prioritize yearly work plans.
- Manage cycle work and continue program refinement to control costs and increase productivity.
- Coordinates with contract workforce to relocate or reassign forestry crews as required, to support maintenance and capital project timeframes and externally driven work.
- Keeps apprised of project schedules, and pro-actively responds to changes.
- Collaborates with personnel in the assigned area to evaluate and resolve reliability concerns, keeping management apprised of progress.
- Exercises authority to approve or disapprove forestry work to ensure compliance with state and federal policies, standards and contract provisions.
- Monitors contractor productivity to maximize return on expenditures.
- Oversees program to inspect work sites or audit completed work to ensure compliance with specifications and directs actions to correct problems.
- Anticipates needs, coordinates, and may direct forestry resources during storm emergency operations.
- Maintains a high level of customer satisfaction related to forestry operation.
- Point person in the assigned area to manage and resolve customer concerns by using appropriate interpersonal styles and communication methods.
- Communicates escalated issues and responds to key executives.
- Confers with real estate, legal, landowners, and municipalities to interpret complex easement rights and resolve line clearance issues and disputes.
- Involves local law enforcement personnel when necessary.
- Attains expert level proficiency with systems and processes used to initiate, manage and track forestry work.
- Based on job assignments may perform key business system support roles including:
 - Functions as the primary point of contact to employees and contractors for training, issues resolution, and general support.
 - Support the ongoing maintenance of GIS and non-GIS data. Develop and manage the processes to ensure data availability, accuracy, completeness, and integrity.



- Perform data mining to ensure quality operations and develop process improvement initiatives.
- Participates in community activities and external industry organizations as a representative of the company to increase safety awareness and advance good forestry practices.
- Functions as company technical expert for all Vegetation Management issues, including interface with media personnel.
- Develops and maintains comprehensive forestry-related literature and website information.
- Responsible for managing budget dollars to meet program goals, and for independent review, correction, and approval of all forestry contractor invoices.

WHAT YOU NEED TO HAVE:

- Associate degree in Forestry, Environmental Science, or related field.
- Prior field-related forestry or ROW Vegetation Management experience. (Internship experience may be included as relevant experience).
- Certification as an ISA Arborist or ability to gain certification within a year of starting employment.
- Must obtain and retain State of Wisconsin Pesticide/Herbicide Applicators License.
- Must have solid tree identification skills.
- Must be able to read maps.
- Must have exceptional written and verbal communication skills, strong problemsolving abilities, the ability to multi-task, and attention to detail.
- Must be able to work alone, outdoors in various weather conditions and terrain.
- Must have basic computer skills (Microsoft Office).

- Bachelor's degree in Forestry, Horticulture, Urban Forestry, or a related field preferred.
