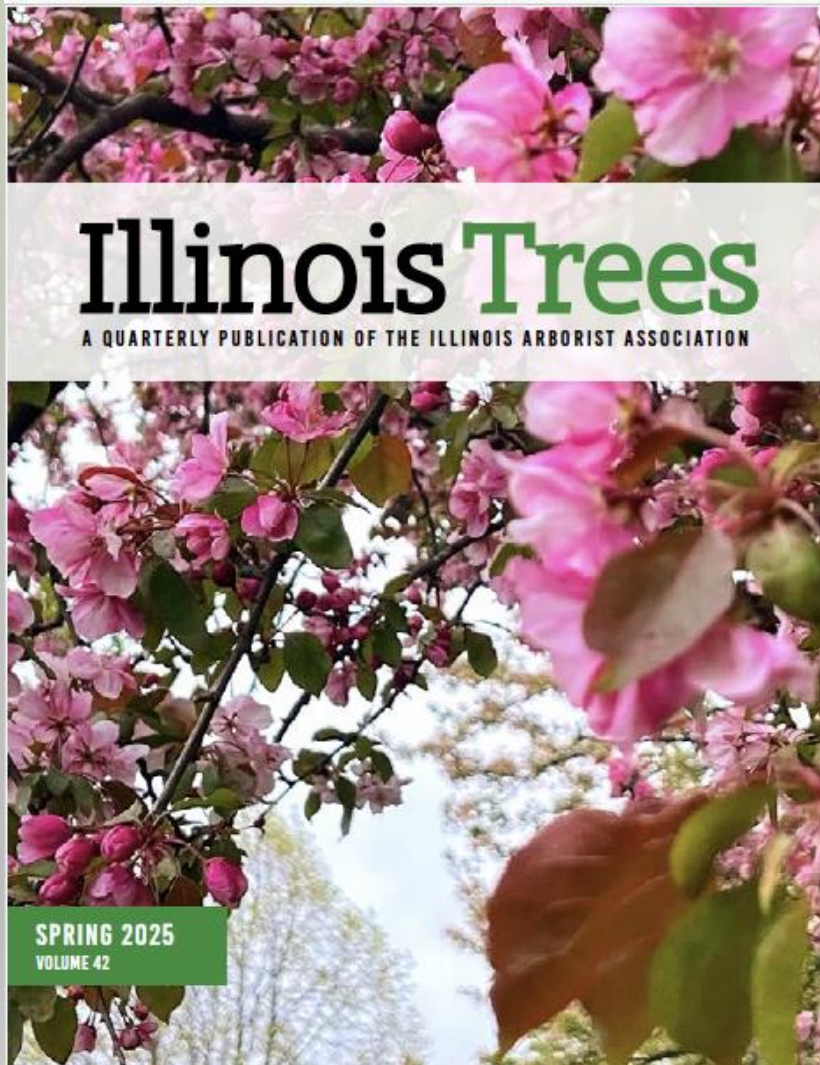

Confirmation of multiple ad runs must be placed at one time, in one email, to receive the frequency discount. When confirming ad space for multiple issues, the advertiser must specify in which issues ads are to run (Spring, Summer, Fall and Winter). The same ad will run in multiple issues *unless* the advertiser has provided a replacement ad prior to the closing date of the specified issue.

**AD SPECIFICATIONS:** *Electronic ad, 300 dpi minimum. JPG, TIFF and EPS are acceptable.*

*Ads should be at 100% to scale. If sending EPS, fonts must be embedded. Files under 30 MB can be sent by email to [april@illinoisarborist.org](mailto:april@illinoisarborist.org). Files over 30 MB can be uploaded to free storage sites, i.e., Dropbox, etc.*

**BILLING:** No need to send a check now. You will be invoiced for your advertisement approximately one week after the mail date of the issue your ad appears in. Please confirm invoicing contact person and billing address by email. Payment will be due within 30 days unless other credit arrangements have been requested and approved.
